FREDONIA-POMFRET SAFETY AND MISBEHAVIOR GUIDELINES

Misbehavior includes: foul language, name calling, hitting, fighting, playing unfair, not following rules of activity, unauthorized use of telephone, unauthorized use of building and play equipment, damaging property, or any activity that may result in injury of oneself or others or damage to supplies, equipment or property in that play area. The following policy will be enforced should misbehavior occur:

1. Verbal warning to child with parent notification from the recreational attendant.
2. Written warning sent home in which parent must sign to acknowledge misbehavior. Child will not be allowed back unsupervised by parent or guardian until form is handed back in.
3. Child must be accompanied by parent, guardian or sitter, 16 years or older when visiting play area.
